FINANCIAL STATEMENT

San Francisco State University does not have financial aid for international students and employment is rarely permitted. Therefore, you must have satisfactory evidence that you will have adequate funds to meet your financial needs when you enroll at the University. Currently, tuition per semester for undergraduate students is \$1,881.00 plus \$339.00 per unit. As an undergraduate student, you are required to take at least 12 units a semester. Tuition per semester for graduate student is \$2,235.00 plus \$339.00 per unit. As graduate student, you are required to take at least 8 units a semester. **Fees are subject to change without notice.**
